
Content Spotlight: Indigenous Peoples and Colonialism in the United States





November is National Native American Heritage Month, a time to celebrate Indigenous communities across the United States.

Historically, curricula have overlooked the history and experiences of American Indians, especially in regard to Thanksgiving. Though widely celebrated as a day of gratitude and togetherness, the holiday is, for many Indigenous people, a reminder of the lasting effects of colonization, including the genocide and displacement of their people and the erasure of culture.

This month is an opportunity for students to build their understanding of colonization, indigenous history, and the ongoing challenges Indigenous people face, such as

loss of their ancestral homelands and the effort to reclaim sovereignity. By understanding our nation's roots, students can recognize the importance of supporting Indigenous communities today.

Compelling Question

Staging the Compelling Question

Introduce students to the themes of the compelling question by displaying the Native Land Digital interactive map. Search your school's address to learn about the territories, languages, and treaties associated with the Indigenous lands you are on. To conclude, present the compelling question to students and discuss it in the context of what they learned from the interactive map.

Explore the Supporting Questions

For each supporting question, students will complete the accompanying formative assessment by exploring primary and secondary sources.

Indigenous Peoples and Colonialism in the United States

Inquiry

Grades 6-8

3 weeks (based on 60 min. periods)

Summative Performance Task

Students will demonstrate their understanding and consider historical and current events related to Indigenous land rights and power in the United States.

Argument: Construct an argument in the form of an essay in response to the compelling question using specific claims and counterclaims supported by relevant evidence.

Extension: Research developments related to land rights and Indigenous peoples, such as the Land Back Movement. Think about how current efforts to reclaim land are influenced by history and government policies.

Taking Informed Action

Provide students with the opportunity to apply what they have learned to issues currently affecting Indigenous communities across the United States.

Understand: Learn about current legal challenges affecting Indigenous peoples in the United States by researching topics such as land and resource rights and voting rights.

Assess: Choose an issue you would like to explore, and research how Indigenous communities are addressing the challenge.

Act: Decide the best approach to support the cause, such as generating awareness, writing a letter to a government official, or supporting a petition campaign.
